<u>RIDING RING RENEWAL PROJECT</u>: Lili Walker, Stephanie Marasciullo, Steve Penner were present to support EMID investment in the horse arena renewal and maintenance. Mr. Penner recounted his years as 4H Horse Project leader and hope that the ring will be renewed. EMID get costs for replacing the watering system removed several years ago.

Director Soltysik asked that Ms. Walker bring a cost proposal to be discussed at the April budget workshop meeting. Director Langle spoke in support of the project. Director Riharb suggested that EMID make a reasonable investment in the project.

<u>FINANCE OFFICER'S REPORT</u>: Financial reports were reviewed. The Finance Committee met on Monday, March 8, 2015 at which time the invoices, checks, bank balances, and account reconciliations were reviewed. Director Bowman presented the income & expense reports and budget to actual reports.

MANAGER'S REPORT: The entrance sign was repaired after receipt of insurance payment. The driver's accident insurance paid EMID \$1013.67 for damage claim. The cost to repair the sign was \$460.00. Entrance culvert dead trees were removed by EMID. The park strip adjacent to the creek near the riding ring was cleared of brush, dead trees and weeds. Tecolote Meadows pathways were cleared and brush along Farren Road cleared. The oven electronic temp control was replace.
