Responsibilities and Term:

- Must be over the age of 18
- Must be a registered voter of the District
- Must reside within the boundaries of the Embarcadero Municipal Improvement District
- Must be a legal citizen of the United States
- The appointed Board member will serve until the general election in November, 2018. The appointed Board member may then put his/her name on the November, 2018 general election ballot.
- Serving on the board will require a commitment to attend monthly Board Meetings the second Wednesday of each month (holiday schedules may apply) and Committee Meetings. Other requirements include, but are not limited to, the following:
- Ethics Training, per CA AB1234
- Sexual Harassment Training, per CA AB1825
- Annual Statement of Economic Interests (Form 700) reporting per the California Fair Political Practices Commission
