<u>ARBOR PROJECT</u>: After some lengthy discussion about possible alternatives to constructing an Arbor, such as umbrellas for tables, pop-ups, and an awning over the courtyard, Director Riharb moved not to proceed with the Arbor project. The motion was seconded by Director Bowman and passed by the following called vote:

<u>DISTRICT WATER USE</u>: In a effort to comply with the Governor's request for a 20% reduction in water use, EMID will investigate ways to do so. The matter will be placed on the May agenda for review and discussion.

<u>DIRECTOR COMMENTS</u>: Director Marotto brought up traffic speed in the canyon and asked that staff place a note on Nextdoor Embarcadero site in an effort to remind drivers about safety on our streets. Director Langle noted that there is an upcoming EPOA sponsored Wine Tasting Party.
